Protests of Renewal**

Under the provisions of Article 2B, Section 10-301(a), an alcoholic beverage license may not be renewed without a hearing when a protest has been filed against the renewal of the license. All hearings concerning protests of renewal will be held in Room 215, City Hall, 100 N. Holliday Street.
